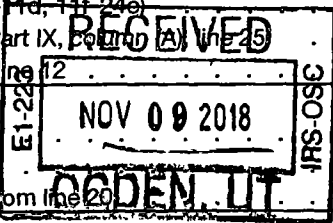

The year ended December 2017 was a transition year for The Fort Foundation. Rental revenue was down about \$30,000 from 2016 due to a decline in performance by the on-sight operations manager. He has been terminated. Operating expenses were much lower in 2017 compared to 2016. The largest cost for the year involved the adjustment to the real estate holdings to reflect the lower of cost or market. This non-cash adjustment amounted to just over \$100,000 for the year. Unlike prior years, The Foundation did not sell any of its real estate. Long-term debt was reduced by about \$10,000 during the year.
