For the year ended December 31, 2018 revenue from the rental of affordable housing increased 37% from \$32,866 to \$45,031. The primary reason for the increase is that more residences were made available to the low-income families than were available in 2017. This improvement was offset by the loss of almost \$19,000 on the sale of a property at less than book value. This property was considered beyond restoration for a reasonable expenditure of funds. Also 2018 operating expenses increased over 2017 primarily as a result of a medical insurance program for two of the three employees costing The Foundation just over \$15,000.
