WE WERE NOTIFIED THAT THE ST. VRAIN VALLEY SCHOOL DISTRICT NEEDED OUR HELP TO NOT ONLY CONTINUE SERVING STUDENTS IN NEED, BUT MANY MORE STUDENTS IN ADDITION. THANKFULLY, WE WERE GRANTED ENOUGH FUNDING SPECIFIC TO COVID RELIEF, THAT WE WERE ABLE TO PURCHASE ADDITIONAL FOOD AND PROVIDE AN EXTRA 11,000 BAGS OF FOOD FOR CHILDREN IN NEED LAST SPRING. HENCE, THE AMOUNT WE SPENT ON FOOD FOR INCREDIBLES IN 2020 WAS MUCH HIGHER THAN WHAT WE BUDGETED, BUT WE WERE ABLE TO RECOUP THOSE FUNDS THROUGH SPECIAL DONATIONS AND GRANTS. FOR 2021, OUR PLAN IS TO CONTINUE OUR MEALS ON THE STREET AND INCREDIBLES PROGRAMS AT CURRENT LEVELS. WE ARE CONCERNED THAT DONATIONS AND FUNDING MAY DECREASE THIS YEAR AS THE ECONOMY CONTINUES TO STRUGGLE. WE ANTICIPATE THAT WE MAY SEE MORE HOMELESS AT MEALS ON THE STREET AND WE MAY NEED TO EXPEND MORE FUNDS TO PROVIDE FOOD AND CLOTHING FOR THAT POPULATION. WE ARE ALSO AWARE THAT HOSTING EVENTS MAY CONTINUE TO BE RESTRICTED IN 2021, LIMITING THAT AVENUE AS A SOURCE OF INCOME. WE HAVE BEEN SERVING THROUGH THIS PROGRAM FOR OVER 23 YEARS. FOR 2020 COF SERVED 2,709 MEALS AND ON AVERAGE SAW 51 HOMELESS EACH WEEK. 142 SERVERS, 14 DRIVERS, 5 COOKS, 6 DISHWASHERS AND 5 HOT DRINK MAKERS VOLUNTEERED FOR MEALS ON THE STREET THIS YEAR FOR A TOTAL OF 1200 VOLUNTEER HOURS. SOME OF THE ITEMS WE GAVE OUT TO THE HOMELESS:459 COATS, 1882 PAIRS OF SOCKS, 422 PAIRS OF LONG UNDERWEAR, 261 SLEEPING BAGS, 517 PAIRS OF PANTS 829 SHIRTS AND 300 PAIRS OF GLOVES. EXPLANATION OF YEAR END FINANCIAL STATEMENTS AND 2021 GOALS: WITH THE ONSET OF THE COVID-19 PANDEMIC, 2020 BECAME AN UNPREDICTABLE YEAR. THE GREATEST CHALLENGE FOR COLORADO FRIENDSHIP CAME IN SERVING THE CHILDREN IN OUR INCREDIBLES PROGRAM BECAUSE THEY WERE LEARNING FROM HOME AND NOT AT SCHOOL WHERE THEY NORMALLY RECEIVE THEIR WEEKEND FOOD BAGS FROM US. THE SCHOOL DISTRICT BEGAN PROVIDING WEEKDAY LUNCH FOR THE CHILDREN AVAILABLE FOR PICK UP AT VARIOUS SCHOOLS AND WE WERE ABLE TO DISTRIBUTE OUR BAGS OF FOOD FOR THE WEEKENDS AT THESE PICK-UPS AS WELL. WE WERE NOTIFIED THAT THE ST. VRAIN VALLEY SCHOOL DISTRICT NEEDED OUR HELP TO NOT ONLY CONTINUE SERVING STUDENTS IN NEED, BUT MANY MORE STUDENTS IN ADDITION. THANKFULLY, WE WERE GRANTED ENOUGH FUNDING SPECIFIC TO COVID RELIEF, THAT WE WERE ABLE TO PURCHASE ADDITIONAL FOOD AND PROVIDE AN EXTRA 11,000 BAGS OF FOOD FOR CHILDREN IN NEED LAST SPRING. HENCE, THE AMOUNT WE SPENT ON FOOD FOR INCREDIBLES IN 2020 WAS MUCH HIGHER THAN WHAT WE BUDGETED, BUT WE WERE ABLE TO RECOUP THOSE FUNDS THROUGH SPECIAL DONATIONS AND GRANTS. FOR 2021, OUR PLAN IS TO CONTINUE OUR MEALS ON THE STREET AND INCREDIBLES PROGRAMS AT CURRENT LEVELS. WE ARE CONCERNED THAT DONATIONS AND FUNDING MAY DECREASE THIS YEAR AS THE ECONOMY CONTINUES TO STRUGGLE. WE ANTICIPATE THAT WE MAY SEE MORE HOMELESS AT MEALS ON THE STREET AND WE MAY NEED TO EXPEND MORE FUNDS TO PROVIDE FOOD AND CLOTHING FOR THAT POPULATION. WE ARE ALSO AWARE THAT HOSTING EVENTS MAY CONTINUE TO BE RESTRICTED IN 2021, LIMITING THAT AVENUE AS A SOURCE OF INCOME. OUR SUCCESSFUL FUNDRAISING IN 2020 HAS LEFT US WITH A BANK BALANCE OF APPROXIMATELY 212,000. WE HAVE SET A BUDGET FOR 2021 OF 255,000 WITH A POTENTIAL INCOME OF ONLY 210,000 WITH THE EXPECTATION THAT WE CAN DRAW ON THIS BALANCE SHOULD INCOME DROP ALLOWING US TO CONTINUE TO SUCCESSFULLY PROVIDE OUR PROGRAMS TO HELP THOSE IN NEED.</p>
