In Fiscal Year 2017, IRC's Center for Economic Opportunity (CEO) continued to build its capacity to serve as a centralized lending platform accessible by community-based organizations that wish to offer accessible, small-dollar loan products to their clients. CEO's primary loan products are Credit-Building, Auto, and Microenterprise loans, and each loan product is designed to be nested within a broader and related economic empowerment program operated by our partners. For now, CEO is only partnering with IRC offices as we continue to build out features and streamline processes. (Continued on Schedule O) During the fiscal year, CEO became operational in 5 offices in 4 different states. From 10/1/2016 through 9/30/2017, CEO originated 384 new loans totaling over \$700k in financing. 97% of loans went to low-income borrowers, and 2/3 had no or poor credit. Borrowers came to the U.S. from 38 countries, with 2/3 of borrowers in the country for less than 3 years at time of loan disbursement. CEO's portfolio remains healthy, with historical repayment rate of 98.3%.
