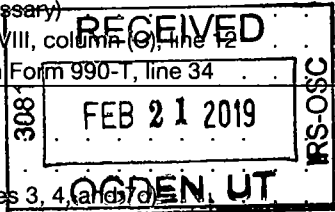

Mercy Clinic of Fort Worth exists to show Christ's love and compassion to the underserved population in the community.

Mercy Clinic provides health care to uninsured, underinsured adults living in central Fort Worth. The clinic is currently open two nights per week and is staffed by volunteers. No charge is made to any patient for services provided. Medical services include lab (on site and in partnership with a local laboratory), health education, and pharmacy. In fiscal year 2018, 1,805 unduplicated patients received services with 1,848 prescriptions filled on-site. Effort is also made to meet emotional and spiritual needs of patients

4b (Code) (Expenses \$ 20,493 including grants of \$) (Revenue \$)
Dental care among the uninsured and underinsured population is difficult to obtain. Currently, Mercy Clinic provides dental care five nights per month. Approximately twenty percent of the population served by Mercy Clinic are dental patients. These patients receive complete dental examinations with x-rays, a treatment plan, and follow up appointments for extractions, fillings, root canals, and basic hygiene. All dental care is provided without charge to the patient. Services are provided by volunteer dentists and assistants.

4c (Code:) (Expenses \$ 8,569 including grants of \$) (Revenue \$)
Two community health fairs are sponsored by Mercy Clinic each year. These events address health education, provide back-to-school vaccinations, flu vaccines, mammograms and other health and safety initiatives. In fiscal year 2018, additional initiatives serving the community included a mammogram clinic and adult vaccine clinic (tetanus, meningitis, pneumonia, hepatitis B). Hundreds of adults and children attend each event. Total attendance in fiscal year 2018 exceeded 950.

Educational opportunities included dental hygiene, nutrition, child seat safety, water safety, fire prevention, exercise demonstrations and attention to physical and spiritual wellness. These events are available to the community at large.
