Mercy Clinic of Fort Worth provides health care to uninsured adults living in central Fort Worth. Open two days per week, the medical providers and other health professionals are all volunteer. The estimated value of their services during fiscal year 2019 is \$250,000. Medical services include lab (on site and in partnership with a local laboratory), health education, and pharmacy. In fiscal year 2019, 1,925 unduplicated patients received services. Spiritual and emotional needs of patients are also addressed.

4b (Code:) (Expenses \$ 20,728 including grants of \$) (Revenue \$)
Dental care is provided five nights per month. Such care is especially difficult to obtain among the uninsured and underinsured population. Care provided includes complete examination with x-rays, a treatment plan, follow up appointments for extractions, fillings, root canals and hygiene services. All dental care is without charge to the patient and is provided by volunteer dentists and assistants. Approximately twenty percent of the population served by Mercy Clinic are dental patients.

4c (Code:) (Expenses \$ 10,102 including grants of \$ 4,649) (Revenue \$)
A community health fair sponsored by Mercy Clinic is held twice each year. Vision and diabetes screening, flu vaccines, mammograms and back-to-school vaccinations are provided. Other health and safety initiatives include dental hygiene education, drowning prevention, and fire prevention. School supplies are provided at the summer event. Besides the two health fairs, other community events in fiscal year 2019 included mammogram and adult vaccine clinics. Total attendance exceeded 1050.

1) Health and Dental Clinic - Patients of the health and dental clinics must be over 18, have no access to health or dental insurance, and live in Fort Worth in a zip code currently served by Mercy Clinic. First time patients are asked to provide a photo ID, proof of residency such as current utility bill and a pay stub, if employed. No cash assistance is provided to patients. Pharmaceuticals and lab work are available at no cost to the patients. The value of all non-cash assistance, including volunteer professional services is estimated at \$533,000 for fiscal year 2019.

2) Community Outreach - During fiscal year 2019, Mercy Clinic held two health fairs (July and November) and free adult vaccine and mammogram events in partnership with community resources, attendees received free flu vaccines, mammograms and exams, school supplies, back-to-school vaccinations, blood pressure checks, and vision screening. Educational opportunities included dental hygiene, nutrition, child seat safety, water safety, fire prevention, and attention to physical and spiritual wellness. These events are available to the community at large.
