Rebuild homes in communities affected by natural disasters, which in turn provides our teenage and young adult volunteers the opportunity to help those in need while exercising leadership skills. Since inception (including our predecessor organization) we have sent nearly 4,000 volunteers on relief trips, helping rebuild over 200 homes, 16 of which we have fully funded, and we provided debris removal for 11 homeowners.
