JFCS Senior Outreach and Support serves frail seniors 60 years and older living in Collier County and southern Lee Counties. The program is open to all socio-economic groups. Services include Geriatric Case Management, Dementia Respite Support, Information and Referral, Volunteer Friendly Visiting, Volunteer Friendly Driving and Holocaust Survivors' Care and Advocacy. 562 seniors received services through the JFCS Senior Outreach and Support program.

The Naples Senior Center is open to all denominations of adults 60 years of age and older to help them maintain a healthy, satisfying quality of life by providing services and activities in a nurturing environment. The Naples Senior Center has more than 1,216 members and offers a wide range of programs for seniors including exercise programs led by trained volunteers, art classes, gardening, Italian and Spanish classes, card games, Dakim Brain fitness, Chess for Brain fitness, computer assistance, weekly education programs on numerous topics of interest to seniors and our flagship program, Lunch and More, a free weekly congregate hot lunch program followed by either entertainment or a lecture. During Lunch and More 4,588 lunches were served to seniors.

JFCS Mental Health Services address the mental health issues experienced by individuals as they struggle to cope with anxiety, depression, bi-polar disorder, and life-cycle issues such as divorce, death or loss of job, substance abuse and/or parenting challenges. Mental Health Services are open to all ages. In addition to individual counseling JFCS provides couples counseling, family counseling and special support groups for Bereavement, Caregivers and seniors living alone. 89 individuals received support through the JFCS Mental Health Services program.
