1) Veggie RX Prescription Program: Veggie RX is a program that provides fresh, local food to participants who are referred by their physician because they have a diet-modifiable disease. Each participant is given \$185 in vouchers over a 6 week period of time to spend at the local farmers market. In addition our registered dietitian gives them recipes and nutritional information that will hopefully alter their food choices. There were 94 participants, with an expanded impact to their additional 100+ family members, resulting in a in approximately 3,565 meals. In addition, \$11,883 of food purchased benefited Central Oregon farmers.

4b (Code:) (Expenses \$ 126,511 including grants of \$ 7,172) (Revenue \$ 47,476)

Food Access: Our organizational vision is to ensure that all Central Oregonians have access to fresh, locally grown, raised and products. The programs that reflect that vision include: 10 Community Food Project which a) prepared 484 Fresh Harvest Kits for community members at local food banks, including fresh locally grown produce, typical food pantry items, and recipes giving families ways to cook with whole food products. In addition, 17,852 pounds of locally grown food was donated to NeighborImpact, our local food bank. In addition we held classes for 92 home cooks to learn how to cook on a budget using fresh, locally grown food

4c (Code:) (Expenses \$ 36,853 including grants of \$ 2,241) (Revenue \$ 43,425)

Supporting Central Oregon farmers and ranchers: Farmer Support: this program provides education, training, marketing, consultation and support to farmers and ranchers in Central Oregon. Annually we publish the Central Oregon Food & Farm Directory, which is distributed to over 45,000 households through the regional newspaper and at local distribution points. This publication makes it easy for community members to access fresh, local food which is healthier and more delicious than food that has been transported from outside the area.
