ALL OTHER ACCOMPLISHMENTS THE INDY HUNGER NETWORK OPERATES SEVERAL PROGRAMS DESIGNED TO IMPROVE NUTRITION, ACCESS, AND SUSTAINABILITY OF THE HUNGER RELIEF SYSTEM IN THE GREATER INDIANAPOLIS AREA, WITH THE GOAL OF ENSURING THAT ALL WHO ARE HUNGRY HAVE ACCESS TO THE NUTRITIOUS FOOD THEY NEED. COOKING MATTERS IS A SIX-WEEK COURSE THAT TEACHES BASIC COOKING SKILLS AND NUTRITION INFORMATION TO PEOPLE WHO ARE USING FOOD ASSISTANCE. CLASSES ARE TAUGHT AT COMMUNITY CENTERS, SCHOOLS, CHURCHES, DAY CARE CENTERS, AND FOOD PANTRIES ACROSS MARION COUNTY. COMMUNITY COMPASS IS A MULTI-PLATFORM TECHNOLOGY TOOL THAT PROVIDES PEOPLE WITH EASY ACCESS TO INFORMATION ON FOOD ASSISTANCE THROUGH THEIR PHONES AND COMPUTERS. OUR FOOD PANTRY NETWORK IS AIMED AT SUPPORTING FOOD PANTRIES THROUGHOUT THE CITY BY CONNECTING THEM TO EXPERTS AND TO EACH OTHER. THROUGH OUR ANNUAL FOOD PANTRY NETWORKING SUMMIT AND QUARTERLY FOOD PANTRY MEETINGS IN EACH TOWNSHIP, WE ARE WORKING TO HELP PANTRIES COLLABORATE WITH EACH OTHER AND IMPLEMENT BEST PRACTICES. THE FOOD DROP PROGRAM PROVIDES DONATION INFORMATION THROUGH WWW.FOODROPIN.ORG TO TRUCK DRIVERS WITH REJECTED LOADS OF FOOD THAT THEY WISH TO DONATE RATHER THAN DUMPING IN THE LANDFILL.
