Explanation: Previous years we filed form 990N which we did as best we could. Upon realizing we needed to file form 990EZ this year, we saw that it was going to be beyond any of our volunteers ability to complete so we started calling around for tax preparer help. We were always told they were not taking any more clients. Also our Executive director has been previously houseless and in process of obtained housing. Also our accounting software had changed mid year which meant a lot of extra time needed to learn the new procedures. Also our bank went out of business (Albina Bank) and we had to transfer accounts which caused difficulties with out bookkeeping procedures. After all this one of our members did a lot of reading to see if he could complete the 990EZ and finally found a website that helped walk us thru the process which you are now receiving. We intended to comply with the law at all times and diligently kept searching for a solution. We intend to comply in the future and ask for a waiver of penalties due to our reasonable causes.
