YOUTH DEVELOPMENT Our YMCA is committed to nurturing the potential of every child and teen. We believe that all kids deserve the opportunity to discover who they are and what they can achieve. That's why we help young people cultivate the values, skills and relationships that lead to positive behaviors, better health and educational achievement. Our YMCA programs, such as summer day camp, swim lessons, aquatics safety programs, daycare, preschool, 4K programs, dance, gymnastics, cheerleading, sports classes and leagues and enrichment classes, offer a range of experiences that enrich cognitive, social, physical and emotional growth. As a result, 13,400 youth in our community benefited from YMCA programs. In 2016, we provided \$58,986 in financial assistance to people who otherwise may not have been able to afford to participate.
