WE SERVED A TOTAL OF 100 FAMILIES, 100% OF WHOM RECEIVED AT LEAST ONE SERVICE FROM OUR PROGRAM; THE MOST POPULAR SERVICES PROVIDED TO PARENTS WERE FOOD ASSISTANCE, CLOTHING ASSISTANCE, AND ESL ADULT CLASSES.

During the 2019-2020 school year Stonewall served 142 children and 132 families. The Stonewall grant maintained full enrollment and exceeded our 10% requirement of serving children with disabilities. We ended our program year with 85% of our children having health insurance, 93% having a dental home, and 98% having a medical home. Over 50% of our families had fathers that participated during the program year. Despite the pandemic, the Stonewall grant was able to continue all program service delivery by virtual means. We hosted parent meetings on Zoom and Microsoft Teams and even started a virtual fatherhood initiative, Men in Action, during Spring 2020. This initiative was led by one of our program fathers due to his desire to see other dads actively involved in their childrens lives and in their community. Stonewall accumulated 53 community partnerships during the 2019-2020 program year and continues building upon those partnerships and develop new partnerships for Blanco and Gillespie counties. During the pandemic the Stonewall staff ramped up their Facebook page use and engagement like never before. In February 2020 the Stonewall Facebook page had 208 likes. By August 31, 2020, the page had 267 likes, a 28% increase! AKW grant provided education services for 337 children during the 2019-2020 school year. Of the 337 children served, 95 were classified as homeless and 11 were in the foster care system. At the close of the school year, 95.84% of our children were/had been covered by health insurance, 100% had a medical home and 100% of Head Start and 98% respectively in Early Head Start had dental homes. Head Start had 12% of those served with an IEP (Individualized Education Plan) and Early Head Start had 13% with an IEP. Grant total was 12% with IEPs which indicated that they had at least one disability and were eligible for special education and related services. Below is a list of activities that occurred at our partner sites and stand-alone centers. Popular services given to our families include parent education (Love and Logic), health education, health services (provided through our EMD branch), and father/male engagement activities.
