Covid-19 Relief - During the pandemic, Food Brings Hope was able to provide assistance to many needy families and individuals no matter their age. Assistance was provided through food bags delivered to schools, home deliveries, and drive through food pantries. Over 13,000 food bags were distributed serving 8,500 families representing over 36,000 individuals. Approximately 23,640 pounds of food were distributed at the drive through food distribution at Mainland High School over a 6-week period. Volunteers donated 2,500 hours to the effort.
