School Based Health Centers (SBHC) - Addressing health disparities and barriers to primary care, eight School Based Health Centers (SBHC) serve students in Omaha Public Schools. Funded by BHF and operated by our collaborative partners, the SBHCs provide 16,000 acute, chronic, and well-child care visits for physical and mental health services provided to over 10,000 unique children from birth to 19 years of age.

Child Vision Collaborate (CVC) - Focused on creating a coordinated system for vision care that includes education, screening, diagnosing, and treatment for under-served children in our city's most impoverished communities, the CVC aims to improve access to vision care, and is working to address the vision needs of all students in OPS.

Child Oral Health Collaborative (COHC) - Inclusive of cross-sector partners, the COHC works to maximize impact on child oral health status in the Omaha community by aligning services across the continuum of care and working with partners to ensure promising practices are implemented. COHC partners provided over 13,000 oral health services in 51 schools and community organizations. Services included oral health education, fluoride varnish, sealants restorative care, tele-dentistry, and care coordination.
