<p>28 Promoting Civic Engagement and Community Organizing We are a nonprofit incubator and social change accelerator We believe in the power of grassroots community organizations and work with new projects and initiatives to determine their best path forward Side Project provides fiscal sponsorship, management and grant support for new and innovative projects focused on progressive social change We help social change agents and groups implement new programs, bring together groups to collaborate on an issue, and test new approaches to social change Fiscal sponsorship is a common mechanism used in the nonprofit sector that enables individuals and organizations to start new programs without establishing a new, separate nonprofit organization The infographic below provides an overview of how fiscal sponsorships work In 2018, we undertook several initiatives focused on creating a more inclusive and welcoming community This included the OpenUp PGH project, the Western PA Disability History and Action Consortium project, the Interdependence Network Program, and the Pittsburgh Center for Autistic Advocacy The OpenUp PGH project offered inclusive yoga and improve theater to more than 100 students with and without disabilities in Pittsburgh The Western PA Disability History and Action Consortium project is working to preserve and honor the historic struggle of Western Pennsylvanians with disabilities to attain human and civil rights The Consortium also educated the public about disability history both online and in several live presentations The Interdependence Network (IN) is a community of practice organized by individuals and human service organizations from around the United States, Canada and Australia Members have committed to shifting their emphasis from the traditional medical model approach to rehabilitation to an interdependence model, which builds and fosters social capital and social inclusion within communities as the primary strategy for enabling people with disabilities to become full members of society The group continued to meet and share emerging best practices The Pittsburgh Center for Autistic Advocacy seeks to advance the equity of autistic people in all realms of life PCAA believes in inclusive education, policy, and community for autistic people and all people with disabilities (Grants \$ 75,254)</p>	<p>28a</p>	<p>88,999</p>
