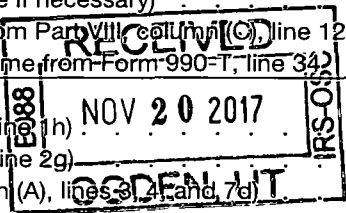

The mission of SquareOne Villages is to create self-managed communities of low-cost tiny houses for people in need of housing. SquareOne serves people who are extremely low-income (below 30% of area median income) and very low-income (below 50% of area median income) and who have no or inadequate housing.

Emerald Village Eugene (EVE) is a permanent, affordable housing project which will contain 22 tiny homes for very low income households. EVE residents will form a self-managed co-op which will lease the facilities from SquareOne Villages. Property for EVE was purchased in 2015. Construction will begin in 2017. Completion is anticipated by the spring of 2018, though the first residents will begin moving in before the end of 2017. Residents are all required to contribute 50 hours of sweat equity to the project in addition to 10 hours of monthly service. Rents will range from \$250 to \$350/month and will include a \$50 payment to the co-op membership for 30 months; providing residents with a real asset that will be sold back to the non-profit if and when they move out. Once that membership is paid up, the monthly rent will decrease accordingly. Residents must be in the village for one year before their membership is fully vested.

4b (Code:) (Expenses \$ 68,050 including grants of \$) (Revenue \$ 1,675)

Toolbox and Consultation The core services of SquareOne Villages (SOV) works to promote self-managed communities of low cost tiny houses for people in need of housing in Lane County and other communities across the U.S. SOV provides consultation services to many communities in various states across the U.S who are seeking low-cost, innovative solutions to homelessness. An online toolbox, funded by a grant from Meyer Memorial Trust, provides resources for communities and groups seeking to replicate the SOV model.

4c (Code:) (Expenses \$ 55,974 including grants of \$ -0-) (Revenue \$ 9,307)

Opportunity Village Eugene provides transitional shelter for the homeless in a self-managed community of tiny shelters for approximately 35 adults at a time. In 2016 a total of 56 were provided shelter at Opportunity Village. Twenty-two moved out during the year. Of these 6 successfully transitioned into permanent housing, 3 were reunited with family and one was admitted into a treatment facility. A MSW intern was added to the program in the fall of 2016 to work with clients on transition plans.
