HUNGER: THE AFTER SCHOOL BACK PACK PROGRAM PROVIDED ALMOST 10,000 BAGS OF ESSENTIAL NON-PERISHABLE FOOD TO JACKSON COUNTY ELEMENTARY AGE STUDENTS DURING THE SCHOOL YEAR.
