The Community Residential Rehabilitation (CRR) Program is a rehabilitative guidance program is designed to offer assistance to adults with chronic psychiatric disabilities. The services provided by CRS via this CRR program make available a gateway for these adults to develop and foster the skills necessary to allow them to live independently. CRS currently offers CRR program services in three locations in the Beaver County, Pennsylvania region. The first location is a full care CRR for up to twelve (12) adults. Since this is a full care CRR, staff are present when clients are on location. The other two locations are each partial care CRR for up to eight (8) adults where staff are scheduled onsite on a regular basis, including evenings and weekends. CRS provides secure home-like accommodations and its CRR program services provide opportunities for clients to contribute to their living communities in significant and meaningful ways by working side-by-side with staff in partnership. This includes CRS staff and clients working together to: 1. Maintain a clean living environment; 2. Achieve the maximum level of autonomy, independence, and self-motivation to better one's circumstances; 3. Discuss and develop money and financial management skills; 4. Self-administer and regulate medications. CRR program services are transitional in nature. The length of stay required depends on the unique needs and circumstances of the respective adult clients.

The CHI Support Program, also referred to as the Stone Harbour Program, is a program that offers apartment-style living for clients with a behavioral health diagnosis that are also experiencing homelessness, drug and/or alcohol addiction, and have a history of legal troubles. Stone Harbour provides a safe, therapeutic transitional environment that promotes independence and recovery. Support personnel offer case management services as well as outreach supports. The length of stay in the CHI Support Program is offered at numerous locations in the Beaver County, Pennsylvania region. Client participation in this program is limited to 24 months. CRS receives grant funding annually from HUD to support this program. This year, CRS received a grant in the amount of \$389,302 that has been reported as a contribution on this Form 990.

The Supported Housing program is a program designed for people who are ready for independent living, but who do not want to live alone. Each implementation of this SH program involves three people choosing to live together, maintain their own leases, and work as a unit, with some assistance from CRS personnel, to maintain and manage their home. Services provided by CRS under the SH program include, but are not limited to helping clients: 1. Maintain housing eligibility; 2. Access community resources; 3. Take advantage of reliable transportation; 4. Become an active, participating member of the community; 5. Develop personal financial management skills; 6. Access and utilize appropriate psychiatric services. CRS currently provides SH program services to over sixty clients in the Beaver County, Pennsylvania region.

Revenue and expenses attributable to this program were \$180,088 and \$194,535, respectively.

This Youth Supported Housing Program is similar in nature to the Supported Housing (SH) Program; however, targets a younger population. Funding for this trial program is expected to be a one-time funding allocation from Beaver County. Revenue and expenses attributable to this program were \$159,819 and \$157,387, respectively.
