In-school programs harness the power of team educators and scientists to allow students to explore large auditorium-based presentations and demonstrations during school-time. Seeds to STEM provides all materials and supplies for a fully interactive educational experience through discovery-style learning. Students are encouraged to engage in exciting experiments that facilitate curious exploration and investigation of the wonders of science. This program brings science, technology, engineering, and mathematics to children who may not otherwise be exposed to such disciplines.
