FOOD IS DONATED BY INDIVIDUALS, CHURCHES AND GROCERY STORES; CASH IS RECEIVED FROM INDIVIDUALS, CHURCHES AND BUSINESSES. CENTRAL PA FOOD BANK GIVES FOOD, GRANTS AND SPECIAL PRICING TO THE COMMUNITY CUPBOARD OF ELIZABETHTOWN. MEALS ON WHEELS IS ANOTHER PIECE OF THE FOOD MINISTRY. IN CONJUNCTION WITH THE LANCASTER COUNTY OFFICE OF AGING MEALS ARE DISTRIBUTED ALMOST EVERY WEEKDAY TO THOSE APPROVED. THERE ARE APPROXIMATELY 10 VOLUNTEERS WHO DONATE OVER 15 HOURS A WEEK.</p>
