Activities that occur there include but are not limited to, a commissary kitchen, an event space, offices where non-profit organizations may deliver services, educational classes, and civic meetings.

Civic Engagement services are those facilitated community conversations, quantitative analysis and collaboration activities that we conduct. As a result, hundreds of local adults are now engaged in community-building activities like neighborhood improvement, crime reduction and healthy eating.

Rockwood English Language Institute (RELI) is a program for adults who do not speak and/or read/write English. We educated 73 adults in 2016.
