The accounts payable amount due MedHealth arises because MedHealth furnishes a contract physician to the Clinic for an arms'-length fee.

Physicians who practice medicine in Texas must comply with many state and federal laws, including Texas' Corporation Practice of Medicine (CPOM) doctrine. CPOM prohibits corporations from practicing medicine in Texas and from employing physicians. To secure the services of a physician, organizations like the Clinic enter into agreements with entities such as MedHealth to supply a physician who is MedHealth's employee to work with the Clinic for a fee payable to MedHealth. Thus, no CPOM-prohibited employment relationship exists between the Clinic and the physician.

The Clinic's arrangement with MedHealth dates from 2014. In December, 2019, MedHealth contributed \$10,000 to the Clinic's fund raising dinner, becoming a substantial contributor.

The accounts payable amount, arising from physician services in 2017 and 2018 was originally \$144,984, but has been steadily paid down by the Clinic. The balance at December 31, 2019 was \$48,328, and has been fully paid at the time of filing this Form 990.
