<p><b>28</b></p> <p>During the past school year, McBackpack, Inc with over seventy regular volunteers, packed and delivered in excess of 12,057 food bags for Poudre School District children in 45 different schools. Children were identified by counselors and other staff as being in need of such nourishment at home. Approximately 80% of those food bags were family bags, which provide weekend foods suitable for a family of 4-5 persons. Since 2011, McBackpack, Inc has packed and delivered 80,337 bags of food attempting to fulfill our vision of ensuring that a child's ability to learn is not compromised by the lack of nourishing food over the weekend. We prepare individual food bags suitable for one child, a family bag for the entire family at home, a high school bag for students living on their own, and a special bag for families who have lost their homes, are in shelters, or living in tents, sheds, or cars. The volunteers work 33-35 weeks of the school year, and it is estimated that the work of the volunteers would cost over \$150,000 to duplicate within the school system. We maintain a close and collaborative relationship with both Poudre School District and the Food Bank for Larimer County. Food is donated by charities, philanthropic community groups, and individuals.
