Project 1649 provides youth (transitional living home residents, community case management participants, and in-school workshop participants) with opportunities to learn and develop important independent living/life skills

In 2018, the transitional living homes served 32 youth 85% of residents graduated or were attending regularly, 94% of exits were to safe housing situations, 85% obtained or increased employment, and 78% increased their self-sufficiency score in 2 or more of 5 key areas measured
