Groundwork RVA - Groundwork RVA facilitated immersion in the National Park System at multiple locations, including Yellowstone National Park, Grand Teton National Park, Shenandoah National Park. In all, about 24 teens from Richmond, Virginia made first-time trips to parks and worked with programs such as Youth Conservation Corps and NPS staff to learn about Park management, natural wildlife, trail building, and conservation. Groundwork RVAs growing partnership with National Parks exposes youth to pathways in park employment and leadership.

UAC-In 2017 Richmond high school students with the Urban Archeology Corps (UAC), a partnership between the National Park Service and Groundwork RVA, unearthed the life, times, and material culture of Maggie Lena Walker, coinciding with the unveiling of Richmonds unveiling of the Maggie L Walker statue on July 19th2017. The Urban Archeology Corps worked NPS Maggie Walker Historic Sites archivist to reveal the ways that Ms Walkers life in Richmond, and her time in Church Hill, Northside, and Jackson Ward reflects important facets of the legacy of African American heritage in Richmond in the decades following the Civil War. The teens will explored the methods of archeological and archival research at the Black History Museum, Maggie Walker Historic Site, Virginia Historical Society, and the Library of Virginia. In 2017, Groundwork RVAs Green Team program made headlines when teens worked with a citywide task force to collect new data on the impact of heat on the citys built environment and the health of its inhabitants. During a heat wave in July of 2017 Groundwork RVAs Green Team youth leaders collected ground level data using temperature sensors during extreme heat events in Richmond. The teens mapped routes that would capture diverse landforms across their communities and collected heat data during three hour-long transects in Richmond neighborhoods. Their data was coded to GPS coordinates and illustrated by the Science Museum of Virginia. Based upon the data collected, the teens are innovating cooling strategies through strategic use of planted materials in Richmonds hottest heat islands. (Cond on Schedule O)
