Ready Set Smile (RSS) in an innovative school-based program that helps hundreds of underserved Minneapolis children achieve better dental health through preventive care and education. In Fiscal 2017, RSS partnered with five Minneapolis elementary and four preschools with high percentage of low-income families who are under resourced and face barriers to having a home dental clinic for their children. 768 children received preventative dental care and over 1200 participated in hands-on classroom education on oral health and nutrition. The Minneapolis schools we partnered with are: Jefferson Elementary, Loring Elementary, Stonebridge, Sojourner Truth Academy, Ascension Catholic Elementary. Minneapolis preschools we partnered with are: BabySpace, Family Partnership North, Family Partnership Four-Winds and Joyce Preschool. Working with school administration we register students at multiple school events and parent-teacher conferences. We find that 30-40% of the children we see do not have dental insurance and RSS providing preventative dental care and education is decreasing decay and increasing knowledge about the importance of oral health. RSS meets the needs of families who have Medical Assistance but cannot find a dental clinic willing to bill Medical Assistance. On site dental care removes the barriers for these families. Our data showed that 48% of the children had active and untreated decay at our first school-year visit. Our clinic and education lessons delay decay significantly and suggests a halo effect on the broader school community. Children who are identified as urgent, benefit from a third fluoride treatment.

Community Health Workers who represent the communities we serve, bridge the barriers and work with the families and school staff to ensure every child receives professional dental care now and the information to be decay free.
