ACHIEVEMENTS IN SAFE SPOT COMMUNITY PROGRAM (1/1/2017 THRU 6/30/2017): CSS OPERATED FOUR SAFE SPOT COMMUNITIES BETWEEN JANUARY 1ST 2017 AND JUNE 30TH 2017. DURING THIS TIME 126 INDIVIDUALS IN NEED OF SAFE SHELTER WERE SERVED AND 42 PEOPLE WERE ABLE TO MOVE ON TO A BETTER LIVING SITUATION DURING THEIR STAY. A NEW PART-TIME EMPLOYEE WAS HIRED FOR THE POSITION OF ACTION PLAN ADVISOR WHICH STRICTLY FOCUSES ON WORKING WITH SAFE SPOT CLIENTS ON THEIR SELF-IDENTIFIED GOALS AROUND HOUSING, HEALTH, EMPLOYMENT, ETC.
