Other: Part III Line 4a - Program Service Accomplishments: AYA Youth Collective is the result of the recent merger between two of the largest organizations serving unsafe/unstably housed, or literally homeless youth, ages 14-24, in Kent County: 3:11 Youth Housing and HQ. AYA creates safe spaces for youth in crisis to belong, be themselves and build a future through a continuum of essential services from prevention and early intervention, to system navigation, advocacy, and non-time-limited supportive housing. Providing a streamlined, one-stop shop for youth to engage in services and be connected to housing resources is crucial in changing the trajectory of their lives (Slesnick et al., 2009). AYA is actively working to disrupt the cycle of homelessness by creating meaningful connection points where youth begin to journey beyond past trauma and form new pathways to healing and hope. Youth are a unique population; experiencing homelessness at a higher rate than any other group, while also being at a higher overall risk because of their stage in development. Unfortunately, the 2020 Point in Time Count showed over 900 individuals sleeping on the streets in Grand Rapids on any given night, and specifically that the number of homeless youth ages 18-24 increased by 66%,

and parenting youth experiencing homelessness increased by 31%. Furthermore, data collected over the past year has shown that 80% of youth receiving the services of AYA are people of color, yet they only make up 41% of the total local population, while 30% identify as LGBTQ+, compared to 10% of the national population. Data clearly shows the overrepresentation of youth in homelessness, specifically with youth of color and LGBTQ+ youth. Youth experiencing homelessness have often faced trauma, are unsure who to trust, and find it challenging to connect with the right resources to find stability and move forward in their lives. AYA is providing access to a continuum of essential services for youth experiencing homelessness. We utilize a low barrier, relational approach through open drop-in hours at HQ, conveniently located in downtown Grand Rapids. During this time, youth are provided basic needs items, access to lockers, private bathrooms and showers, a laundry area, and an inventory of toiletries, personal items, clothing, full meals and snacks, all available at no cost. AYA Youth Advocates and diverse community partners form trusting relationships with youth and offer support through vital document recovery (i.e. social security cards, ID cards, birth certificates, etc.), education and employment services, culturally appropriate therapy and wellness activities, and non-time limited supportive housing. AYA currently operates nine homes (two dedicated to parenting mothers, and one for youth who identify as LGBTQ+) throughout Kent County with the capacity to house 24 youth, ages 18-24, at any given time. Duplex style homes allow for 3-4 youth to reside in one unit and an on-site House Mentor in the other. Youth pay \$300 per month in rent and utilities, with an opportunity to receive a scholarship towards their rent and security deposit upon moving out. Youth also sign leases to foster ownership and responsibility of the property. On-site House Mentors provide guidance as youth navigate real world situations, such as employment, money management, and fostering healthy relationships. Community is created through weekly house dinners

and holiday celebrations. Local partnering agencies provide case management support and assist youth in setting short-term, mid-term, and long-term goals. AYA is also committed to providing continued support and after-care upon move out, as is seen through our robust, and actively engaged, alumni network. AYA has a vision for a community where all youth have a place to call home, where every person is valued for their contribution to the community, and where youth empower each other to make lasting changes in their lives. We believe that safe and secure housing is a basic human right, and that all youth deserve the opportunity to be supported and find success in life.
