Form 990-EZ, Part III, Section 1, Line 28	<p>In August 2017, the Board of Directors of Stone Soup adopted a long-term Vision Statement which included moving our operations to a single site in order to continue to prepare and serve meals 365 days of the year. This site needs to have a spacious dining room, a dedicated and fully licensed kitchen, adequate pantry space and cold storage space and a location that would be easily accessible to clients and acceptable to nearby residents. In early 2018 Stone Soup Corvallis Inc., began to implement this vision and a restricted capital campaign fund was established to raise funds to meet these goals. Rental space was offered at a reasonable rate in a suitable location, but funds were needed to install and equip a commercial kitchen and suitable pantries as well to remodel the dining area with sufficient restrooms. We initiated arrangements with a lawyer, and architect and contractors. These plans eventually came to naught because the offer of suitable rental space was withdrawn in late summer. Since the Board is hopeful that there will eventually be a new opportunity to realize this vision, we have retained the remainder of the capital campaign funds for this venture. We will maintain these contributions as restricted funds for a future meal site.</p>
