THIS BROUGHT THE TOTAL NUMBER OF CLIENTS SERVED ABOVE 600 WOMEN SINCE OPENING ITS DOORS. THE LOSS OF OUR CAREER CENTER COORDINATOR, AND A PHYSICAL MOVE AT THE END OF THE YEAR, RESULTED IN A LOWER NUMBER OF WOMEN BEING SERVED.
