We have received a notice of a penalty for late filing for our 2018 990 notice CP141L, which is in error.

We have tried numerous times to contact someone at the phone number listed on the notice but have been unable to get through.

We are sending this packet to request elimination of all penalties and to provide documentation for response to notices received.

- On May 5th, 2019, we filed for an extension until November 15, 2019, which was granted.
- On September 30th, 2019, our completed form 990 was mailed out. We did not send this packet certified, however.
- We received Notice CP120C in December of 2020 regarding non receipt of two years of 990's which was in error. We then sent copies of both the 2018 and 2019 990 along with copies of the certified mail receipt for the 2019 990.
- We are now in receipt of the notice of penalty for the 2018 990.

Enclosed is a copy of the UPS receipt for delivery of both the 2018/2019 990 copies as well as the certified mail receipt for the original 2019 990.

We are also sending along another copy of the 2018 990.


