The RATL ASAP was created in order to allow RATL mothers to gain and maintain meaningful employment, and serves to alleviate constant worries about where their child is, what they will eat, and how they will complete academic requirements. The RATL ASAP provides students transitioning out of homeless with the opportunity to maintain a high level of academic achievement as children in permanent housing possess. Each day, students receive one-on-one tutoring, social and behavioral programming, meals, and recreational time that allows them to learn, play, and grow outside the classroom. The ASAP provides crucial structure and support to each and every child in RATLs care while allowing their mothers the freedom to build a foundation for the future of their families.

Form 990, Part III, Line 4b:

Restoration ATL Summer Camp (RSC) served an average of 40 students each day with programming for 9 hours per day/45 hours per week (at no cost) while their mothers worked to overcome homelessness. RSC provides children transitioning out of homelessness with an engaging and safe environment to immerse themselves in recreation, continued academic training and spiritual development during the summer. RSC activities center on furthering development academically and spiritually, while simply offering kids a chance to enjoy their break from the often harsh realities of the school year. RATLs goal is to see them mature socially and spiritually, sending them back into the academic year better prepared for new challenges. RSC also addresses the need for RATL mothers to continue working full time. RSC activities include community worship, breakfast and lunch, engaging with Bible stories, skits, arts and crafts, academic advancement, recreational activities, character-building activities, and team lessons.

Restoration ATLs (RATL) Spiritual Development Programming serves an average of 25 mothers and 60 children per week with Family Bible Study, Ladies Bible Study, and Pastoral Counseling as families work to overcome homelessness. RATLs Spiritual Development includes weekly on-campus Family Bible Study, Ladies Bible Study, and pastoral counseling for families transitioning out of homelessness. RATLs Spiritual Development programming is a refuge, and offers an opportunity for the women to put aside the weight and worry of their circumstances, and focus solely on the Word of God. Bible Study and worship nights allow residents to be saturated in the encouragement and beauty of Scripture, to uplift and edify one another, and to develop an intimate relationship with Jesus Christ.
