Part III, Line 28 SAFE distributed \$35,539 worth of food purchased from local stores and \$69,000 (est) worth of donated in-kind food to low income families in Alamance County NC. SAFE served 1721 families representing 4269 family members in 2017. SAFE is being supported by local businesses, organizations such as school groups, boy and girls scouts, local restaurants and churches. Currently SAFE is operating a food pantry and has partnered with a local low income medical clinic, a church sponsored community garden and the local community college. The community garden and local farms donate fresh produce and eggs. The local community college is providing GED training as well as literacy and other job training courses for our population. SAFE will be sponsoring quarterly health fairs providing screening and education. SAFE provides a box filled with meats, milk, eggs and fresh produce and a paper grocery bag filled with nonperishable food approximately 40 pounds of food per family per month.
