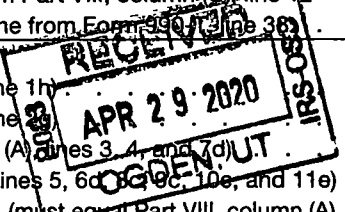

**The outreach and education program has over 40,000 conversations in the Twin Cities metro raising awareness of commercial food waste. These conversations don't just affect people's view of the world but also drive fellow citizens into action. Business owners, store managers, farmers, gardeners, and other community members participate with the FoodShare, Community Garden and Community Meals program because of their contact with canvassers. In addition we find and start communication with local non profit workers that guide the focus of our work. Our other programs are informed by the outreach program. We educate our neighbors and they return in kind.**

**Community Meals: our vision for community meals is to involve our foodshare and garden programs in serving hot meals to people in need in the twin cities. In 20019 our preparation for this program included purchase and repair of a food truck.**

**FoodShare: We partner with businesses metro wide including but not limited to grocery stores, food co-ops, distributors, and food production facilities. We take the perishable food products: produce, meat, bread, dairy, that these businesses know they would have to waste without our help. Our output in the last year has been approximately 5,000 pounds per week. That's more than 250,000 lbs per year. Our workers are food industry professionals that ensure rapid and safe transportation of the food to be used by Twin Cities non profits everyday. We do not sell this food to the foodshelves, shelters, and other non profits allowing them to concentrate their resources on their mission instead of healthy food.**
