The Organization's goal is to provide basic primary care, dental, and mental health services to the families and visitors of Wallowa County. Winding Waters Medical Clinic currently operates at locations in Enterprise and Joseph, Oregon. The Organization provides health care services to patients who meet certain criteria under its charity care policy without charge or at amounts less than established rates. (Continued on Schedule O) Because the Organization does not pursue collection of amounts determined to qualify as charity care, they are not reported as revenue. The amount of charges foregone for services provided under the Organization's charity care policy was approximately \$149,000 for the year ended December 31, 2018. Total direct and indirect costs related to these foregone charges was \$180,000 for the year ended December 31, 2018, based on an average ratio of cost to gross charges.
