We collected thousands of bras, underwear, pads and tampons who are in need, such as women experiencing homelessness, low or no income and incarcerated women. Also ministering with individuals in the neighborhood of Southern Barton Heights, a community 1/2 mile from the largest public housing complex in Richmond, VA and others outside the neighborhood. This includes weekly fellowship gatherings in small groups to talk about things of God, share life together through preparing and eating a meal and helping to meet the needs of the community. It also includes regular activities hosted to increase trust, deepen community relationships and strengthen community organization.
