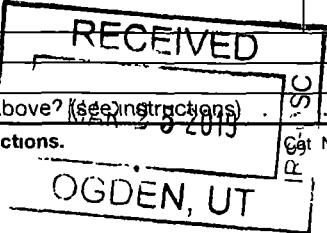

is still with us and probably will be at least another 6 weeks.
We continue to have Cane Center women and Scarlet Rope women that volunteer with us on an intermittent basis while they
are in recovery/reemployability. One woman was with us, mandated, for about 16 weeks-8 hours a week and she continues to
come back when she is not at her regular job now.
We have had 3 Leadership University high school students volunteer for their required hours
We continue to partner with ARM in serving their clients. Some of their service programs have been cut/done away with, so we
frequently get requests for help with bus passes, emergency shelter if there is no room in the inn that night or nutritional needs
