HELEN'S HOPE CHEST IS AN ORGANIZATION DESIGNED TO PROVIDE CLOTHING, SCHOOL SUPPLIES, AND OTHER BASIC NEEDS ITEMS TO FOSTER CHILDREN. SINCE ITS ESTABLISHMENT IN 2009, AS A PROGRAM OF MESA UNITED WAY, HELEN'S HOPE CHEST HAS MORE THAN TRIPLED THE NUMBER OF FOSTER CHILDREN SERVED THROUGHOUT THE PHOENIX METROPOLITAN AREA. THE PERSONAL NAVIGATOR'S PRIMARY ROLE IS TO PARTNER WITH KIDS IN FOSTER CARE, STARTING AT AGE 14. THE NAVIGATOR'S MAIN JOB IS PREPARING OUR KIDS TO BUILD SUCCESSFUL AND FULFILLING LIVES. IN NOVEMBER 2020, HELEN'S HOPE CHEST, THROUGH THE FOSTER 360 PROGRAM, WILL OPEN A MULTI-RESIDENT FACILITY TO HOUSE FOSTER CHILDREN THAT ARE TURNING EIGHTEEN AND AGING OUT OF THE FOSTER CARE SYSTEM.
