THROUGH CLASSES AND ACTIVITIES SPECIFICALLY TARGETING ACTIVE OLDER ADULTS, WE PROVIDE THE 20% OF MEMBERS CLASSIFIED AS SENIORS WITH OPPORTUNITIES FOR PHYSICAL ACTIVITY AS WELL AS SOCIAL CONNECTION.
