The Idaho Diaper Bank purchased diapers in 2016 and received donations of diapers from diaper drive conducted by civic groups, faith based organizations, schools and businesses. Diapers purchased by the IDB are done so through negotiated bulk pricing discounts with diaper manufacturers.

The IDB distributed over 400,000 diapers to more than 40 community partners in 2016.
