<p><b>28</b></p> <p>Helping Hands is a Sherwood community food bank offering assistance to those in need. It was started 28 years ago in the Sherwood United Methodist Church. Even as the Church declines in attendance, the hunger work has continued to grow in size and scope, serving hundreds of families annually in the local area with food boxes containing canned food, fresh dairy and produce. Helping Hands is also involved with four elementary schools, two middle schools and the local high school placing a supply of "kid friendly" food in the schools for counselors and faculty to give out to hungry children during the school day. Helping Hands also administers a back pack weekend meal program to children in the Sherwood school district. School counselors monitor families whose children are on the free or reduced school lunch program and if they feel there is even a chance of insufficient food for the weekend, then they provide a back pack full of nourishing "kid friendly" food on Friday afternoon for the student and their siblings for the weekend breakfast and lunch meals. Helping Hands also sends home flyers in both English and Spanish informing parents on how to use the food pantry to help feed the entire family. The last school year Helping Hands sent home 12,200 meals for school age children. In 2016 Helping Hands launched a summer lunch program for the children who receive back packs during the school year. In 2019 85 children per week participated in the Backpack program. Helping Hands sends out hygiene packs in both the pantry boxes and the back packs containing toothbrushes, toothpaste, floss, bar soap, shampoo, deodorant, etc. In 2019 Helping Hands joined with other groups to provide a free meal every Thursday evening to families and homeless with needs. This program averages serving 30 people each week. Helping Hands has partnered with the Sherwood schools and Sherwood library to provide lunch for 100 children every Thursday for a 6 week summer "Lunch &amp; Learning" in the park program. Helping Hands receives about 16,000 pounds of donated food per year from can food drives by the local schools, faith groups, business and civic organizations. This food is part of the food used to help feed people. Helping Hands also supplies emergency food boxes for the Sherwood police for needy families they come across. Helping Hands also provides snack foods for all the school counselors to keep on hand for hungry children, snacks for the YMCA teen center, and snacks for SHARE. Helping Hands still has a lot of work to do in education. Helping Hands provides fresh fruit, produce and passes along information provided by the Oregon Food Bank on making healthy choices to help curb childhood obesity and type two diabetes. Helping Hands couldn't do this without a core of dedicated volunteers who collect, sort and distribute the tons of food we need each year. We keep this program supplied for our neighbors in need. Helping Hands has no paid staff and volunteers are not reimbursed for any expense they incur. This is a partnership between community and faith groups. Helping Hands goals are to make sure no child in our area goes to bed hungry while emphasizing healthy food choices.
