THE EMERGENCY SHELTER IS A SAFETY NET FOR YOUTH IN CRISIS; AVAILABLE TO YOUTH AGES 16-21. YOUTH IN NEED OF SHELTER MAY STAY UP TO 21 DAYS AT A TIME. YES SERVED 60 YOUTH IN THE SHELTER PROGRAM BUT WAS NOT ABLE TO SERVE 83 YOUTH DUE TO LACK OF SPACE. YES EXPANDED THE MENTORING PROGRAM TO INCLUDE YOUNGER YOUTH, NOT IN THE HOUSING PROGRAM IN ORDER TO PREVENT THEM FROM ENTERING THE JUVENILE JUSTICE SYSTEM.
