COVID PROTOCOLS LED TO YES SERVING FEWER YOUTH FOR LONGER PERIODS OF TIME COMPARED TO PREVIOUS YEARS. YES EXPANDED THE MENTORING PROGRAM TO INCLUDE YOUNGER YOUTH, NOT IN THE HOUSING PROGRAM IN ORDER TO PREVENT THEM FROM ENTERING THE JUVENILE JUSTICE SYSTEM.
