CHILDREN CAN RETURN TO PARENTS, EXTENDED FAMILY, BE ADOPTED OR PLACED THROUGH SUBSIDIZED LEGAL CUSTODY. LVFT ENGAGES THE PARENT IMMEDIATELY UPON THEIR CHILD'S PLACEMENT SO THAT THEY FEEL WELCOMED AND PART OF THE TEAM (THERE ARE RARE EXCEPTIONS FOR SAFETY REASONS).
