During last fiscal year, AMIH provided permanent and transitional housing for over 150 people diagnosed with mental illness in Placer County. Transportation, utilities, case management and groceries were provided to these individuals, many who are homeless or at-risk of homelessness and low-income. Supportive services are provided through with AMIH, Placer County Adult System of Care, and Turning Point Community Programs. During this fiscal year, AMIH began a rapid rehousing programs for homeless families enrolled in CalWorks. The program provided housing assistance for 26 families during its first six months. The program has been renewed for another year and we hope to assist many more homeless families in finding permanent housing & employment.
