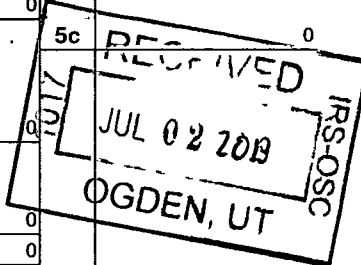

The Big-Brained Superheroes Club purchased valuable robotics platforms, including Micro bit bundles with edge connectors and robotics shields, with which Big-Brained Superheroes build recycled robotics. In this bundle, we acquired power supplies, fabrication equipment (our digital cutting tool--Cricut Maker), and iPods for documentation, data collection, and Micro bit programming. Together, these purchases have been making the creation of 3D interactive artwork a fundamental component of the work over 100 low-income immigrant, refugee, and minority youth do in The Big-Brained Superheroes Club every year.

This robotics platform has been used by over 80 Brained Superheroes in The BBSC and at events since we purchased it in January of 2018. It has formed the basis for our robotic jellyfish, which Big Brains developed and presented at Facebook's BlackInTech hackathon, as well as for the other ocean creatures (sea turtle, crab, angler fish), which Big Brains developed and presented at Seattle Children's Festival and Mini Maker Faire. At these events combined, over 500 people of all ages from all around the globe have engaged with the recycled robots Big Brains have developed using this equipment in 2018, learning about creative reuse and robotics in the process.

One of our biggest challenges came in October-December 2017 in the form of a sudden Yesler Community Center remodel that not only separated Big Brains from their space for over two months but eliminated 1/6th of the room afterward. As part of this project, Big Brains and Big Buddies adapted by designing and constructing our very own MARS (Mobile Artistic Rendering Station).
