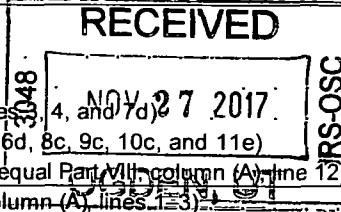

ANNUALLY ALL BOARD MEMBERS AND OFFICERS MUST DISCLOSE ANY INTEREST THAT COULD GIVE RISE
TO CONFLICT. ADDITIONALLY, THE BOARD DISCUSSED EACH PROPOSED EXPENDITURE TO CONFIRM THAT
A CONFLICT OF INTEREST DID NOT EXIST. IF IT WAS DETERMINED THAT A POTENTIAL CONFLICT WAS
PRESENT, IT WAS APPROVED BY THE BOARD, EXCLUDING THE POTENTIAL CONFLICTING MEMBER.
