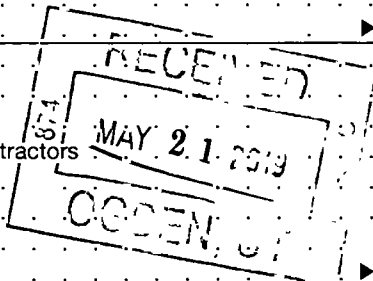



Total program expenses in 2018 were \$30,257; Total Management expenses were \$4,472, total fund raising expenses were \$231.

87% of all expenditures in 2018 supported veteran programs.
