A total of 545 people were served. They work with 20 women during their pregnancies toward a healthy outcome for their substance-exposed infants. Susannah's House provided substance abuse recovery referrals, support and group therapy & classes related to relapse prevention, relationship boundaries, seeking safety, art therapy, physical, mental and spiritual well-being, and parenting. They also provided childcare, wholesome meals, toiletries and hygiene supplies, clothing, and child necessities. Susannah's House assisted mothers with accessing community services such as medical service referrals, employment assistance and court and DCS assistance. They also provided nutrition education and birth control and smoking cessation education in partnership with Knox County Health Department.
